- to assign him/her tasks in accordance with the aims of the internship period and to fill in the attached job description (see Annex to the contract),
- to allocate him/her a subject supervisor,
- to continuously assess the student's placement report and to countersign it,
- to write an assessment of the internship and to present this to the student at the end of the internship period.
- (1) The student guarantees
  - to comply with the rules and regulations of the internship provider,
  - to comply with the working requirements of the internship provider and the designated internship supervisor,
  - to write an internship report and have it countersigned by the supervisor of the internship provider and to hand it to the supervisor at the TH Wildau (within four weeks of the end of the internship period),
  - to present the results of the internship period in a colloquium at the TH Wildau by 30 November of the respective year in which the placement took place,
  - to provide to the supervisor at the TH Wildau at least two interim reports during the internship period, whereby the content and the length of these reports are to be arranged individually with the supervisor,
  - to keep business transactions and information confidential.

(2) The TH Wildau guarantees to support and to supervise the student in preparing for and carrying out the placement period.

This contract does not provide for any right to the reimbursement of any costs which may incur.
