# § 1. Duties of the contract partners

(1) The placement provider guarantees to give work to the student during the period from \_\_\_\_\_\_,

according to the contents of the "Studien- und Prüfungsordnung der TH-Wildau" (Study and Examinations Regulations of the TH Wildau), in particular

- to give him/her work in accordance with the aims of the placement period

- to allocate him/her a subject supervisor
- to continuously assess the student's placement report and to countersign it
  - to write an assessment of the placement and to present this to the student at the end of the placement period

(2) The student guarantees

- to comply with the rules and regulations of the placement provider

- to comply with the working requirements of the placement provider and the designated placement supervisor

- to write a placement report and have it countersigned by the supervisor of the placement provider and to hand it to the supervisor at the TH Wildau by 30 September of the year in which the placement took place

- to present the results of the placement period in a colloquium at the TH Wildau by 30 October of the year in which the placement took place

- to provide to the supervisor at the TH Wildau at least two interim reports during the placement period, whereby the content and the length of these reports are to arranged individually with the supervisor

(3) The TH Wildau guarantees to support and to supervise the student in preparing for and carrying out the placement period.

# § 2 Costs

This contract does not provide for any right to the reimbursement of any costs which may incur.

### § 3 Supervisors

The placement provider designates
